- It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
- It will provide adequate co-curricular and extra-curricular activities for the wholesome development of the students.
- It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
- 7. It will continue to pay Annual Fee of Rs. 5000/- p.a. The schools run by KV/NVS/CTSA/Govt./Govt. Aided/Railways/Armed forces etc. are granted regular affiliation and apply online for Extension of Affiliation through link provided on Board website www.cbseaff.nic.in.under the Government Schools Corner.

- 9. Special condition to be completed within 01 months.
- The School is required to appoint Special Educator as per rule 13(11) of Affiliation Byelaws of the Board and as mentioned in Board's circular dated 25.06.2015.
